Dear Members of the Vestry, Treasurer, Members of the Finance Committee, and Rector of
Church of the Good Shepherd of the Southern Cone:

Please be advised that I represent the continuing Episcopal Diocese of Fort Worth and the
Corporation of the Episcopal Diocese of Fort Worth.

My clients deeply regret the action taken by you and others in November of 2008 to leave
The Episcopal Church and purport to associate with the Anglican Province of the Southern Cone.
By doing so you and others, including the former Bishop of Fort Worth, declared that you and
they were no longer Episcopalians or subject to the Episcopal Church and its Constitution and
Canons.

In February 2009, in consultation with the Presiding Bishop and under canon law, a
special diocesan convention elected the Rt. Rev. Edwin F. Gulick, Jr. as the provisional bishop of
the continuing Episcopal Diocese of Fort Worth.

As a result of the continued actions of the former Diocesan leaders, my clients
subsequently and reluctantly filed a lawsuit to resolve a number of legal issues and as a step to
recover property that has been alienated from the mission and ministry of The Episcopal Church.


My clients still yearn for reconciliation with all who have left the Episcopal Church. But
because you are no longer member of the Episcopal Church, the reality is that you are without
authority to use property or spend funds belonging to Episcopal Church of the Good Shepherd on
or before November 15, 2008. The Episcopal Church and the Episcopal Diocese of Fort Worth
have a trust interest in the parish property currently under your control and a duty to preserve the
legacy of the Episcopal Church, including property given for the use and benefit of the Episcopal
Church and its parishes. That property includes the real property currently occupied by your
group and the personal property and funds currently controlled by your group.

Because you are not authorized as a group or as individuals to use or dissipate this parish property, I respectfully ask that your group please vacate the real property, turn over the personal property, records and funds of the parish to the Diocese, and cease using the name and seal of the parish. In addition, please do not spend, sell or encumber any of the parish property that you currently control until it is turned over to the Diocese. It is our sincere hope that after an accounting you have not incurred any personal liability regarding the parish property and funds during the time they have been under your control.

Please contact me personally or through legal counsel to discuss the details of when and how you will turn the parish property over to the Diocese, for the benefit of the Episcopal parish. I look forward to hearing from you in the hope that we can work to resolve this dispute soon, without further damage to the ministry of The Episcopal Church and the ministry of your new church.
